

Submission of the MSYSA Export Player Form for State Association Approval

MSYSA has a number of Associate State Registrars (ASRs) spread across the state. Those that live near the state boundaries are the individuals that usually review and approve the MSYSA Export Player Forms for MD residents playing in the neighboring state.

In the table below, the neighboring State Associations have been listed along with contact information for the ASRs that will review/approve applications for Out of State Play. A location for each ASR is provided to allow you to select an ASR near you. Depending upon MSYSA's arrangements with each other State Association, you might need to pick up approved paperwork from the ASR – or, it might be possible to complete the process using email.

After the Export Player form has been completed and signed, please scan it into a PDF document and send it as an email attachment to an ASR near your location that processes applications for the State Association for which your child wishes to play. In the Subject line of your email, please use the destination state association acronym (e.g., DYSA, EPYSA, etc.) followed by your child's name. Be sure to include your contact information in the body of the email.
